Eventually fifteen tests, which were thought to fulfill all the necessary requirements, were selected.

After this preparatory work, a pilot study into the feasibility of such a predictive battery of tests was carried out, which involved the testing of a selected group of pupils within secondary school who were studying technical subjects. The predictive nature of the selected tests will be established by correlating the pupils' scores on the tests against their performances throughout the year (As indicated by course work and examination marks in technical subjects.) The fifteen selected tests were administered to these Form I pupils at Soche Hill Secondary School and Chichiri Secondary School, who took technical subjects.

These tests were marked and the scores correlated with the pupil's performances in technical subjects over two terms.

From the results obtained, seven tests were discarded as being poor predictors of technical ability and were administered to a larger sample in five secondary schools (5 schools, sample of 340 pupils). These tests have been marked. I am now waiting for information about performances in the actual subjects. This is to be based on course work, marks and examination results over two terms. From this additional information I hope to produce a final predictive battery of tests.

Description

- The two projects will contribute to the promotion and popularization of the objectives of testing in Pakistan.

The realization of aim No. 1 will enable teachers to make a comprehensive assessment of pupils' achievements in school subjects.

The realization of aim No.2 will help in measuring the level of general intelligence of pupils at the high school level. The proposed test will be based on two factors, i.e. verbal reasoning and numerical ability.
