

Notes on the Authors

Mervyn C. Alexander is the Supervisor of Examinations in the Ministry of Education of Trinidad & Tobago. He is also the local registrar in Trinidad & Tobago of the Caribbean Examinations Council. His career in the government service commenced in 1957 and has included 13 years as Secretary of the National Training Board and Secretary of the Metrication Board.

Leonora Archer is Senior Education Officer in the Testing and Evaluation Section of the Ministry of Education & Training of the Bahamas. She has previously been vice-principal of the government secondary school, and Chief Examiner for the Bahamas Junior Certificate of Secondary Education English Language Examinations. She lectures part-time in the Education Division of the College of the Bahamas.

Sir Roy Augier was Chairman of the Caribbean Examinations Council from 1986 to 1996. He has played an active developmental role in the CXC since its foundation in 1972. He is also a professor of history at the University of the West Indies in Jamaica. In 1996 he was knighted in recognition of his services to education in the region.

Surendra Bissoondoyal is Director of the Mauritius Examinations Syndicate. He was previously an Education Officer in the Ministry of Education, and the first Secretary of the Mauritius Institute of Education. He is also Pro-Chancellor and Chairman of the Council of the University of Mauritius, and Chairman of the *Editions de l'Océan Indien* publishing company. He is also active in the International Association for Educational Assessment, of which he is one of the officers.

Mark Bray is Director of the Comparative Education Research Centre at the University of Hong Kong. He has extensive experience of work in small states, and has written both academic articles and practical resource books on aspects of educational planning and management in small states. Much of his previous work on this topic has been conducted for the Commonwealth Secretariat. He is the editor of *Ministries of Education in Small States: Case Studies of Organisation and Management* (London: Commonwealth Secretariat, 1991); author of *Educational Planning in Small Countries*

(Paris: Unesco 1992); and co-author, with Steve Packer, of *Education in Small States: Concepts, Challenges and Strategies* (Oxford: Pergamon Press, 1993).

Sangay Dorjee is Assistant Secretary for Research and Analysis in the Bhutan Board of Examinations. He has worked for the government's Education Division since 1989, having begun his career as Assistant Administrative Officer for school procurement and supplies. He joined the Bhutan Board of Examinations in 1991. He holds an M.Ed. degree in measurement and evaluation from the University of Manchester (UK).

Jan Erasmus works in the Directorate of National Examinations & Assessment (DNEA) in the Namibian Ministry of Basic Education & Culture. He holds degrees from three universities in South Africa, and has been both a school teacher and a university lecturer in that country. In 1980 he became a subject adviser in what was then called the Department of National Education in South West Africa, and he joined the examinations branch in 1985. He became Deputy Director of the DNEA in 1990.

Dennis Irvine is the Caribbean Regional Adviser to the President of the Commonwealth of Learning. From 1969 to 1982 he was Vice-Chancellor of the University of Guyana. He has also worked as UNESCO Science Adviser to the Caribbean (1983-88), and in 1989 became Director of Caribbean Programmes and Materials Acquisition & Development at the Commonwealth of Learning. Dr Irvine was Chairman of the Caribbean Examinations Council from 1974 to 1979, and retained close links with the Council during the two following decades.

Mohammed S. Khan started his career as a teacher in Guyana. He went on to become a headteacher, education officer, and Deputy Chief Education Officer in the Ministry of Education. He retired in 1997 as Chief Education Officer.

Serara Moahi works in the Examinations Research & Testing Division of the Ministry of Education in Botswana. She has extensive experience of examinations, both locally and internationally, and has written several publications on the topic.

Mike Murtagh is the former Executive Secretary of the New Zealand Universities Entrance Board. During his period of office, he had extensive dealings with authorities in the small states of the South Pacific, and with

the South Pacific Board for Educational Assessment. From 1990 to 1993, he was General Manager of the Assessment and Certification Division of the New Zealand Qualifications Authority.

Matthew Ndure is Head of the National Office of the West African Examinations Council in the Gambia. He has detailed knowledge and long experience of the Council, having worked for it since 1977. He took over the Headship of the National Office in 1995. His early training at university was in the field of English. He obtained a BA (Hons) from the University of Sierra Leone in 1971, and subsequently earned a Dip.Ed. and an M.Ed. from the University of Exeter. He had taught in a high school for five years.

She is now Superintendent of Examinations, and is also Local Registrar for the Caribbean Examinations Council.

He is now a coordinator within the Basic Education and Life Skills (BELS) Programme, which is a regional education project concerned with children's literacy acquisition in Pacific island schools. His career includes lengthy periods of assessment work in Zambia, Swaziland, Brunei Darussalam, Libya and Australia before settling in Fiji.

John Sadler is Deputy Director of the International Development Division, University of Cambridge Local Examinations Syndicate. His main expertise is in Assessment and he helped the University of Cambridge Local Examinations Syndicate to develop the International General Certificate of Secondary Education and the Modular Banking System (MBS). Mr Sadler looks after many projects world wide, including those in Africa and the Caribbean. He joined UCLES in 1986, prior to which he taught in a variety of schools for 25 years. Lafi Sanerivi is Assistant Director of Education, responsible for the Curriculum & Examination Unit of Western Samoa's Department of Education. His formal education includes university studies in New Zealand and Australia. He has taught in secondary schools and also in the Teachers College in Western Samoa.

Gurmit Singh is Programme Manager of the multi-donor regional basic education Basic Education and Life Skills (BELS) programme, which is being executed by the University of the South Pacific (USP) for 11 Pacific island countries. Formerly he was a curriculum coordinator and principal of a training college with the Fiji Ministry of Education. At the USP, he has been involved in teaching assessment and curriculum courses, and in action research especially at the primary school level.

Janet Stanley-Marcano is Director of the Educational Research and Evaluation Division in the Ministry of Education in Trinidad & Tobago. Her career includes 25 years of involvement in teaching and classroom evaluation in primary schools, tertiary institutions and nonformal education. She holds an EdD in Research and Evaluation, and is one of the chief evaluators and researchers in the field of education in the Caribbean.

Michael Steer is former Secretary of the New Zealand School Certificate Examination Board. Since 1990 he has been Manager of Examinations for the New Zealand Qualifications Authority. In these capacities, he has had extensive dealings with the governments and school authorities in the small states of the South Pacific.

Lucy Steward is Chief Programme Officer in the Human Resource Development Division of the Commonwealth Secretariat. Her areas of responsibility include human resource development in small states. He is also the founding editor of the *Mediterranean Journal of Educational Studies*.
